Subject and purpose of the report

This document is prepared within the framework of the BalkanDetox LIFE project (LIFE19GIE/NL/001016) and relates to the deliverable "Worksop/meeting reports from all educational events implemented", defined under Action D.1: Public awareness raising campaign and educational programmes for key target audiences. This report is produced to provide an overview of the implemented workshops and other educational and awareness raising events in the target project countries, aimed at changing perception and attitudes of relevant stakeholder groups for wildlife poisoning and other types of wildlife crime.

About the project

The <u>BalkanDetox LIFE</u> project is a five-year endeavour with a €1.8 million budget, which aims to raise awareness and strengthen national capacities to fight the problem of wildlife poisoning across Albania, Bosnia & Herzegovina, Bulgaria, Croatia, Greece, the Republic of North Macedonia and Serbia. It received funding from the EU's LIFE Programme with a contribution of 1.004.792€ (54,82%) to the total project budget, and it is co-financed by the Vulture Conservation Foundation, the MAVA Foundation and Euronatur, as well as by the Whitley Fund for Nature and Environmental Protection and Energy Efficiency Fund for specific actions. Project partners are the Vulture Conservation Foundation as the coordinating beneficiary, and the Albanian Ornithological Society, Association BIOM, Bird Protection and Study Society of Serbia, Fund for Wild Flora and Fauna, Hellenic Ornithological Society, Macedonian Ecological Society, Ornitološko društvo NAŠE Ptice and the Protection and Preservation of Natural Environment in Albania as associated beneficiaries. Furthermore, this project is based on Spanish best practice experience and counts with the support from the Junta de Andalucía and the Spanish Ministry for the Ecological Transition and the Demographic Challenge.

INTRODUCTION & BACKGROUND

The National educational workshops about wildlife poisoning for the relevant stakeholder groups (livestock breeders, pastoralist, hunters, farmers) have been developed and implemented within the BalkanDetox LIFE Project, a cross border initiative bringing together wildlife conservation organizations, governmental agencies and other stakeholders from seven Balkan countries with a common goal - to combat illegal wildlife poisoning, which is a specific type of environmental crime that is the leading mortality factor for many wildlife species, particularly vultures and other scavengers. The workshops aimed at changing the perception of primarily livestock breeders, pastoralists, hunters, farmers from preselected local communities in the Balkan countries about the use of poison baits for resolving human-wildlife conflict and raising awareness about the dangers of this illegal practice for human health and the devastating effect it has in their environment. These local communities have been selected on basis of the frequency of occurrence of the wildlife poisoning incidents, and they represent some of the most significant hotspots for this illegal practice in their respective countries.

The programme of the workshops focused on the following main topics:

- negative effects that the illegal practice of using poison baits has on numerous wildlife.
- the ecological role and the significance of ecosystem services that are provided by vultures, which are one of the most common victims of wildlife poisoning.
- the danger that poison baits and general misuse of pesticides represents for human health.
- the legal sanctions and penalties for this illegal practice under the national legislation of each project country.

The workshops were organised and implemented by the national project partners.

OBJECTIVES & TARGET AUDIENCE

The overall goal of the workshops, and other implemented educational events, is changing the perception and attitudes of key target audience towards wildlife poisoning, especially the general public, labelling it a socially unacceptable behaviour which has



well documented devastating effects to biodiversity in our environment and building support for conservation initiatives of the project.

The target audience for these workshops were livestock breeders, pastoralists, hunters and farmers, which are stakeholder groups that are most often associated with wildlife poisoning, from local communities which represent hotspots for wildlife poisoning.

The project partners have implemented all educational and awareness-raising events foreseen under this activity of the project. A total of 41 educational event organised and carried out by the national project partners across Albania, Bosnia and Herzegovina, Croatia, North Macedonia and Serbia, reaching directly hundreds of people.





Annex 1

Reports from the National workshops in Albania

- WORKSHOP REPORT 1 & 2 -

Background:

In October 2021, AOS organized two informative-educational workshops with livestock breeders, farmers, hunters, and other people from local community in villages of Radat and Sofratika. Additionally, awareness and informative leaflets about poisoning issue and the threat it poses to threatened species were distributed in Zhulat and Asim Zenel. These villages where this activity was carried out are hotspot areas for poisoning and are selected within this project as areas of priority due to presence of poisoning and the threatened species – Egyptian Vulture.

Workshop Goal:

The main goal was to raise awareness about the issue of wildlife poisoning across hotspot areas.

Workshop Objectives:

- To inform the target audience about wildlife poisoning and its scale, root causes, and its consequences on wildlife.
- To inform and raise awareness about the threatened species Egyptian Vulture about the current situation of EV population in Albania, potential threats for the species, and how the use of poison baits affects its population.
- To inform the target audience about the legal framework that prohibits the use of poison baits and poisonous substances against wildlife, and about the Law on the compensation of damage caused to livestock or crops.
- To make aware why poisoning cases should be reported and where they should be reported.



 To inform the target audience about alternative methods for the protection of livestock and agricultural crops from wildlife.

2. Outcomes/Overall Conclusions of the National Workshop:

- WORKSHOP REPORT 3 & 4 -

Background:

The activities held within this action consisted of raising awareness of the key target audiences about the main issues relating to illegal wildlife poisoning and helping change the local attitudes and mitigate this threat.

Two workshops have been organized by PPNEA, at the beginning of November and the end of December 2022 in Gjirokaster, a hotspot area for wildlife poisoning. Participants in the workshops included shepherds, vets, farmers, and hunters, as well as representatives from the Regional Administration of Protected Areas Gjirokaster, Institute of Food and Veterinary Safety, National Inspectorate for Protection of Territory (Gjirokaster branch) who live in these hotspot areas and are part of the "Savers of the Egyptian vulture", a network created over the years of work done on vultures in Albania.

Workshop Goal:

Increasing awareness of the local community in the Gjirokaster hotspot area, on the phenomenon of wildlife poisoning, through educational workshops implemented within the BalkanDetox project and evaluating the perception of the local community about the practice of poisoning.

Workshop Objectives:

- Presentation of the BalkanDetox LIFE project and describing the main actions of the project, with a focus on the local activities.
- Raise awareness about the negative impacts of this illegal practice, by providing safe alternative solutions in solving human-wildlife conflicts and highlighting their advantages.
- Emphasizing the illegality of wildlife poisoning and the relevant penalties by providing the participants with a complete overview of the legal framework and punitive measures for the use of toxic substances and this illegal practice, already considered an environmental crime.
- o Describing the importance of the involvement, support of the governmental institutions, and collaboration with the local community on this matter.

2. Outcomes/Overall Conclusions of the workshop:

Outcome 1: The local community is informed about the initiative of the BalkanDetox LIFE project and the activities that will be implemented within the project.

Outcome 2: The local community and main target group are informed about the negative impacts of this illegal practice, alternative and friendly methods in solving the wildlife conflicts as well as on the punitive measures for the use of toxic substances.



3. Next steps:

Further workshops will be held throughout the implementation of the project. An awareness-raising campaign is planned to be implemented targeting the local community and key target groups in the defined hotspots in southern Albania. Promotional materials such as leaflets produced within the project will be distributed and additional educational materials will be produced and shared with the community.

- WORKSHOP REPORT 5 -

Background:

This report refers to the awareness-raising activities implemented in June, August and September 2023 under Action D1 of the BalkanDetox LIFE project, aiming to inform and engage key target audiences about the threat of illegal wildlife poisoning in Albania.

The activities in June were conducted in synergy with the Egyptian Vulture monitoring visits in southern Albania, particularly in identified poisoning hotspot areas. These field-based meetings were held with local community members including shepherds, farmers, and other stakeholders who live or work in these vulnerable areas. In September, PPNEA, in collaboration with the Tirana Park and Recreation Agency (APR Tirana), organized a public awareness event in Tirana Grand Park to celebrate International Vulture Awareness Day (IVAD). This event was designed to engage the general public, especially children and youth, in learning about vultures and the threat of poisoning through fun and interactive educational activities.

Goal:

To enhance the public's understanding of the phenomenon of wildlife poisoning, specifically among communities living in hotspot areas and among citizens of Tirana (capital), by promoting educational messages through workshops, field visits, and public events.

Objectives:

- Present the BalkanDetox LIFE Project and provide an overview of its key actions, with a focus on the illegal use of poison and the risks it poses to vultures and biodiversity.
- Raise awareness about the consequences of poisoning and promote safe, legal alternatives to manage human-wildlife conflicts.
- Engage children and families in educational games and activities to cultivate an early understanding and appreciation of vultures and conservation issues.
- Disseminate project materials including educational videos, leaflets, and stickers, to increase the reach and visibility of the campaign.
- Foster collaboration with local communities and institutions for continuous involvement in combating wildlife poisoning.

2. Outcomes / Overall Conclusions of the Meetings:

Outcome 1:

Local communities in the monitored hotspot areas received updated information on the BalkanDetox LIFE project and were reminded of the ongoing threat of poisoning to vultures and wildlife. Engagement in the field created space for open dialogue and mutual exchange of ideas on coexistence strategies.

Outcome 2:

Participants of the IVAD event were introduced to the ecological role of vultures and the dangers they face due to illegal poisoning. The interactive and family-oriented setting proved effective in building positive attitudes and raising awareness among younger generations.

Outcome 3:

Educational materials including games, leaflets, and videos were distributed and used as effective tools to communicate the complex issue of poisoning in a simplified and accessible way.

Outcome 4:



The collaboration with local authorities (APR Tirana) and citizen involvement at a recreational site demonstrated the potential of urban-based outreach to complement rural community engagement, expanding the reach of the project's message.

- WORKSHOP REPORT 6 -

Background:

This report highlights two major awareness-raising initiatives implemented under Action D1 of the BalkanDetox LIFE Project, aimed at informing and engaging the public and local communities about the threat of illegal wildlife poisoning and the conservation efforts being undertaken in Albania.

The first activity took place throughout October 2023, during the national campaign "Albania is Biodiversity", a month-long celebration and public outreach initiative focused on biodiversity and nature protection. From 2–22 October, PPNEA organized daily awareness activities in the capital city, Tirana, targeting citizens through direct engagement. The project's initiatives, including BalkanDetox LIFE, were presented through educational displays, games such as the Egyptian Vulture Board Game, and distribution of project materials like leaflets and stickers.

This campaign reached:

- Over 10,000 citizens visited the awareness stands and displays on-site.
- 1 million people were reached online through social media promotion and coverage.
- More than 20 awareness activities were organized in Tirana alone.
- 920 students were directly engaged through environmental education sessions.
- 200 new volunteers signed up, reflecting strong youth interest in conservation work.

The second activity occurred in May 2024, during the Europe Week celebrations, which were organized in both Tirana (the capital) and in Gjirokastër, one of the hotspot areas for wildlife poisoning in Albania. These events focused on engaging the local community and urban citizens alike, while celebrating European environmental values, with special emphasis on nature conservation and local biodiversity. Materials from the BalkanDetox LIFE Project and the "Albania is Biodiversity" campaign were shared widely across both locations.

In addition to these two large public events, short field visits were carried out during spring and August 2024 in key hotspot areas to maintain communication with local stakeholders, particularly shepherds. During one such visit, it was reported that a shepherd's dog was poisoned, likely due to the ongoing presence of toxic substances in the area. Fortunately, the dog was treated successfully with a veterinary anti-poison kit. This incident indicates that, despite awareness efforts, the illegal poisoning network



remains active in certain areas, highlighting the need for continued vigilance and constant collaboration.

Goal:

To increase public understanding and awareness on the issues of illegal wildlife poisoning and biodiversity conservation, by integrating the BalkanDetox LIFE Project's messages into high-visibility public events both in the capital and in key hotspot areas.

Objectives:

- Promote the objectives and actions of the BalkanDetox LIFE Project to a broad audience through national and regional public campaigns.
- Educate urban citizens and local communities about the dangers of poisoning and the importance of vultures and biodiversity conservation.
- Offer engaging, hands-on activities and visual materials to make complex conservation topics more accessible to all age groups.
- Distribute printed educational materials (leaflets, stickers, info boards) and share visual media (videos and animations) to reinforce key messages.
- Collaborate with institutional partners and other initiatives like "Albania is Biodiversity" to broaden the reach of conservation education and enhance public support.

Outcomes / Overall Conclusions of the Meetings:

Outcome 1: The citizens in Tirana were directly engaged for nearly three weeks during the "Albania is Biodiversity" campaign. Hundreds of citizens visited the awareness stands daily, participated in activities, and received educational materials, creating a sustained and meaningful exposure to the project's messages.

Outcome 2: The use of visual and interactive tools such as the Egyptian Vulture Board Game and coloring sheets during the Tirana event helped communicate complex conservation issues in a fun and age-appropriate way, especially to children and families.

Outcome 3: Europe Week in Tirana and Gjirokastër provided an opportunity to reconnect with both citizens of Tirana and local communities in a known hotspot for wildlife poisoning. The combination of BalkanDetox LIFE materials and messages from the broader biodiversity campaign reinforced the need for local ownership and vigilance in the fight against poisoning.

Outcome 4: Collaboration with local authorities and the visibility during national and European environmental celebrations helped in sharing the profile of the BalkanDetox LIFE Project and expanded its audience across both urban and rural areas.

- WORKSHOP REPORT 7 -

Background:

Workshop Goal:

Raising awareness in Dibra region about the consequences of the illegal use of poison baits in nature and in human health.

Meeting Objectives:

- o Collecting information about wildlife conflicts in the Dibra region.
- Discussing safe alternative methods for resolving conflicts with wildlife.
- Informing different stakeholders about the consequences of the illegal use of poison baits.
- o Raising awareness about the impact of pesticide misuse on human health.

2. Outcomes/Overall Conclusions from the workshop:

Outcome 1: The main wildlife conflicts in the Dibra region involve wild boars and brown bears, which cause damage to crops and beehives. There are fewer conflicts with wolves because sheep graze in pastures for only a short period each year and are kept enclosed for most of the year.

Outcome 2: The local community in the Dibra region is aware of safe alternative methods and actively uses them to prevent damage from wild boars and bears to their crops and beehives. They employ dogs, foxlights, and electric fences. However, there is sometimes an issue with using high-voltage electric fences.

Outcome 3: The educational video on the impacts of pesticide misuse on human health and the informational leaflets about illegal wildlife poisoning, which explain what it is, its consequences, and safe alternative methods, have been shared with all participants.

Outcome 4: Contacts have been established with local institutions and local NGOs.

3. Next steps:

Action 1: Maintaining local contacts for ongoing information exchange regarding the development of wildlife conflicts in the region and for any possible wildlife poisoning incidents occurring in the area.

- WORKSHOP REPORT 8 -

Background:

On September 6th, 2024, AOS, in collaboration with RAPA Gjirokastër, hosted an educational workshop in Përmet with key local stakeholders as part of International Vulture Awareness Day 2024. The event was attended by representatives from RAPA Gjirokastër, the Municipality of Përmet, as well as local residents and farmers.

Workshop Goal:

The goal of the meeting is to raise awareness about the use of poison baits, which pose a significant threat to the Egyptian Vulture (*Neophron percnopterus*) and other wildlife.

Workshop Objectives:

- Raising awareness about the importance of vultures for the local ecosystem and economy.
- o Informing about vulture populations in Albania, with a special focus on the Egyptian Vulture.
- Raising awareness about the harmful effects of poison baits on wildlife and the Egyptian Vulture population.
- Discussing about human-wildlife conflicts in the Përmet region.
- Raising awareness about the dangers of poisonous substances used in bait preparation and their potential impact on human health.
- Sharing information about the conservation measures undertaken by AOS and RAPA Gjirokastër to ensure a safe breeding season for the local Egyptian Vulture pair in Përmet.
- Discussing about effective preventive measures to mitigate human-wildlife conflicts in the Përmet area.

2. Outcomes/Overall Conclusions of the National Workshop:

Outcome 1: The audience, consisting of key stakeholders from the Përmet region with whom AOS has been collaborating to ensure safe breeding seasons for the local Egyptian Vulture pair, was well-informed about the severe threat poison baits pose to the species.

Outcome 2: Local stakeholders were informed about the health risks to humans resulting from the misuse of pesticides and other toxic substances. The educational video on the impacts of pesticides misuse on human health was shared with the audience.

Outcome 3: Information leaflets on illegal wildlife poisoning were distributed to workshop participants. Around 100 of these were provided to RAPA Gjirokastër for further distribution within the local community as part of their awareness program.

Outcome 4: Local stakeholders identified the main conflicts with wildlife in the Përmet region. Conflicts with bears were the most frequent, as they caused damage to crops



and beehives. The wild boar and wolf were also sources of conflict for the local community.

Outcome 5: The methods used by the local community to mitigate conflicts with wild animals include snares, guardian dogs, and electric fences for protecting beehives.

Outcome 6: While stakeholders find electric fences highly effective for protecting beehives from bears, they believe this method is insufficient to address all types of human-wildlife conflicts in the area. They recommend the following strategies as necessary steps to mitigate these conflicts in the Përmet region, and as a way to prevent the use of poison baits: (1) Regular local awareness campaigns on the impacts of poison baits on wildlife and human health, as well as the legal consequences of their use; (2) Government subsidies to compensate for damages caused by wildlife.

3. Next steps:

Action 1: Maintaining local contacts for ongoing information exchange regarding the development of wildlife conflicts in the region and for any possible wildlife poisoning incidents occurring in the area.

- WORKSHOP REPORT 9 -

Background:

On March 5, 2025, AOS held an educational and training session in Vlora with local authorities from three different municipalities: Vlora, Fieri and Divjaka Municipality. The participants represented different institutions and field of expertise, such as: representatives from Municipality of Vlora, rangers from protected areas regional administrations, inspectors from national inspectorate for the protection of the territory, and representatives from State Police.

Meeting Goal:

The goal of this session was to raise awareness among local authorities regarding the poisoning issue and in the same time to share with them some best practices on wildlife crime investigation learned during the Wildlife Crime Academy.

Meeting Objectives:

- o To raise awareness among local institutions about the poisoning problem.
- To understand the difficulties local institutions, face in properly managing wildlife crimes.
- To share some best practices and lessons learned during the Wildlife Crime Academy.

2. Outcomes/Overall Conclusions of the National Meeting:

Outcome 1: The local authorities seem to be more aware about other types of wildlife crime such as illegal shooting and trapping of birds and less of wildlife poisoning, due to the fact that there have been no cases of suspected poisoned wildlife reported to them. Some informative leaflets about the poisoning issue were shared with participants so they can get to know a little bit more about the problematic.

Outcome 2: During discussions a need for collaboration between institutions was highlighted again as well as a need for having a chain of custody in place.

Outcome 3: Participants expressed a need for more training regarding the management and investigation of wildlife crimes.

3. Next steps:

Action 1: Our focus lately has been on pushing forward the approval of the antipoisoning road map, as the road map provides a clearly defined chain of custody and jurisdiction, together with operational protocols which will be very helpful for authorities.

Action 2: Regarding citizens reporting suspected poisoning cases to authorities, we will continue to emphasize through our communication channels, and if possible, through local authorities' communication channels, the importance of reporting poisoning cases to competent authorities.



3. Short description:

This was the second out of three planned educational lectures for local residents (livestock breeders, farmers, hunters) in Croatia's poisoning hotspots (Lika, Dalmatinska zagora and Kvarner region). Lecture was held in Gospić (Lika region, central town in Ličko-senjska county) in the venue of Kulturno-inoformativni centar Gospić. The place of the lecture was chosen due the fact that obligatory educational programs for agricultural subsidies/payment users are regularly organized in the same venue and local farmers are well acquainted with it.

During the preparation of the lecture, additional efforts were put into compiling farmers' personal e-mail addresses in cooperation with Directorate for Professional Support for Agricultural Development (Ministry of agriculture) and sending direct invitations to the lecture. Even though around 500 direct invitations were sent to farmers and hunters, and an open invitation was shared through all local media (online news portals and local radio stations), relatively small number of participants joined the lecture: nine local residents, mostly cattle breeders, and three employees of Public institution Nature park Velebit.

Marija Martinko Ivanov opened the lecture by greeting all participants and making a short introduction on the theme of poisoning and the BalkanDetox LIFE project. The main lecturer was Ivan Budinski, (Biom's employee (mammal expert) and a member of the National wolf and brown bear intervention team). The discussion which followed was lively and open. All present cattle breeders openly talked about the casualties in their cattle herds which are caused by wolf attacks. Many of them openly stated that they have already heard of several other farmers using poison baits. The participants raised practical questions regarding correct actions they should undertake in case of witnessing poisoning incidents in the future and preventive measures against predators. During discussion Ivan Budinski put a strong emphasis on all dangers and consequences of poison misuse, additionally describing them on real past cases of poisoning incidents in Croatia.

Representatives of the media were also informed about the event. Prior to the beginning of the lecture, journalists from two local radio stations (Radio Gospić and Radio Senj) gathered statements from Ivan Budinski and Marija Martinko Ivanov which were aired the next day.

4. Outcomes of the workshop:



Outcome 1: Participants (local farmers – cattle breeders) are informed about the dangers and consequences of poison misuse. They are informed when to suspect of illegal poisoning incidents (how a poison bait looks like, how a poisoned animal looks like)

3. Short description:

This was the final out of three planned educational workshops/lectures for local residents (livestock breeders and shepherds, farmers, hunters) in Croatia's poisoning hotspots (Lika, Dalmatinska zagora and Kvarner region). Lecture was held in town Krk (on the island of Krk, Kvarner region, Primorsko-goranska county) in the venue of the Krk Town Hall (vijećnica Grada Krka).

During the preparation of the lecture, additional efforts were put into compiling farmers' personal e-mail addresses in cooperation with Directorate for Professional Support for Agricultural Development (Ministry of agriculture) and local agricultural cooperative and sending direct invitations to the lecture. Direct invitations via e-mail were also sent to local hunters (members of local hunting association) as well as to the county hunting federation. Even though around 90 direct invitations were sent to farmers and hunters, and an open invitation was shared through all local media (online news portals), relatively small number of participants joined the lecture: four shepherds, two hunters and one employee (director) of County public institution for nature conservation.

Boleslaw Slocinski opened the lecture by greeting all participants and making a short introduction on the theme of poisoning and the BalkanDetox LIFE project. The main lecturer was Ivan Budinski, (Biom's employee (mammal expert) and a member of the National wolf and brown bear intervention team). During discussion Ivan Budinski put a strong emphasis on all dangers and consequences of poison misuse, additionally describing them on real past cases of poisoning incidents in Croatia. Present shepherds openly talked about the huge issue of the golden jackal attacks on sheep, which is the main obstacle for sheepherding on the Island of Krk together with overgrowing pastures. Present shepherds admitted that they do not poison anymore as they became aware of the devastating impact of wildlife poisoning on Griffon Vultures, which they consider a natural ally in maintaining pastures. Present hunters stated that wildlife poisoning results in their economic loss since hunting dogs are often killed on poison baits set for golden jackals.

The main topic of discussion was halting the overgrowing of pastures, which would help them to manage the jackal population more successfully and would also help in raising profitability of sheep keeping. Issues related to pastures management are a burden for all sheep keepers, so when additional problem, such as golden jackal attack appear, some sheep keepers get extremely frustrated and choose poisoning as a method. Director of the local County public institution for nature protection (JU Priroda) Marko Modrić announced that JU Priroda is applying a project for the Cohesion Fund which wound help in restoring Island Krk's pastures and support local sheep keeping. Local farmers stated that they recognize nature protection sector (JU Priroda, Association



Biom) as stakeholders who honestly aim at supporting sheep keeping on Kvarner islands and they are open for further cooperation.

Representatives of media were also informed about the event and shared the invitation on their web portals and social networks. They were also offered to take statements from lecturers for their press releases but none of them showed interest in that.

4. Outcomes of the workshop:

Outcome 1: Participants (hunters and local farmers – cattle breeders) are informed about the dangers and consequences of poison misuse. They are informed when to suspect of illegal poisoning incident (how a poison bait looks like, how a poisoned animal looks like)

Outcome 2: Participants (hunters and local farmers – cattle breeders) are well informed on how to properly act and engage if witnessing or suspecting incidents of illegal poisoning.

Outcome 3: Participants are informed about possible preventive measures against predators they can implement.

2. Outcomes/Overall Conclusions of the National Meeting:
